BJR COVER IMAGE COMPETITION

BJR is essential reading for radiologists, radiographers, radiotherapists, medical physicists and radiobiologists and we are looking for a suitable image for the cover.

The winning image will be selected by the BJR Editorial Board in October 2016 and used on the cover of BJR in 2017.

SPECIFICATIONS

Entries should be supplied digitally in the following formats:

Images must be submitted in **TIFF** or **EPS** format and have a resolution of **300 dpi** or greater. JPG and PNG are compressed image formats and are not suitable for our requirements.

Ensure that the digital files are large enough to fit the image area on the printed journal cover: 210 mm (width) x 260 mm (depth).

Use CMYK (cyan, magenta, yellow, black) or RGB (red, green, blue) for the file colour mode.

You should always submit the largest original file available. Please do not resize the image in any way.

Each image submitted to the contest should be accompanied by a legend (not exceeding 50 words) and provide the following information: title, description, your name and location.

SUBMISSION

Please submit your entry via the BIR website. Entries close 5pm GMT, Monday 31 October 2016. Any entries received after this time will not be considered.

INFORMED CONSENT

If your entry is shortlisted, you will be asked to confirm that you have the appropriate informed consent from the patient to use the image for this competition.

LICENCE TO PUBLISH

Notice: You are the person (referred to as "You/Your") submitting an image (referred to as "the Image") for the BJR 2015 cover competition. We are the British Institute of Radiology (BIR) of 48-50 St John Street, London, EC1M 4DG, UK (referred to as "We/Us/Our").

By submitting the Image to Us you are confirming that you have read and agree to grant and have the right to grant the BIR this licence.

- 4. You retain copyright in the Image. However, should We choose to, You authorise Us to act on Your behalf to defend Your copyright in the Article should anyone infringe it, and to retain half of any damages awarded after deducting Our costs.
- 5. We are entitled to assign Our rights under this licence to any third party without giving notice to You.
- 6. No change or modification of this licence will be valid unless confirmed in writing by Us.
- 7. Failure or delay by Us to exercise any right or remedy under this Agreement shall not be deemed to be a waiver of that right or remedy, or prevent Us from exercising that or any other right or remedy on any occasion.
